

## MINUTES OF THE 38th ANNUAL GENERAL MEETING OF THE MALAYSIA AUSTRALIA BUSINESS COUNCIL HELD ON THURSDAY 27th JULY 2023 5:00 PM AT THE AUSTRALIAN HIGH COMMISSION, KUALA LUMPUR

Mr. Nordin Abdullah ("the Vice-Chairman) presided as the Chairman of the meeting. The Chairman called the meeting to order at 5:00 pm after confirmation of the requisite quorum being present pursuant to Article 13(i) General Meeting quorum is one-half of the total voting membership of the Council, or twice the total number of Executive Committee, whichever is the lesser shall be present.

1. Address from Chairman

Apologies for Dato Peter not being present in the meeting, with Mr Nordin Abdullah to present a short summary written by Dato Peter in his address.

Noted that MABC has been very busy at work within the last 12 months, particularly regarding subcommittees improving governance and cleaning up debts. Treasurer also presents these details to members.

Mr. Abdullah acknowledged MABC known for their significant networking events, mentioning Penny Wong's recent visit, and noting MABC plays a critical role in the business agenda between Australia-Malaysia relationship. It is stated that MABC intends to continue building upon this work, growing business relationships in Malaysia by collaborating with the Australian High Commission, different state governments and agencies in Kuala Lumpur.

Mr Abdullah notes MABC will play a more significant role in advocacy, business engagement and more trade-related delegations between Malaysia and Australia over the next 12 months.

Matthew Barsing updated the floor that the procedure the secretariat team took is aligned with the constitution, with a final payment notice reminder before the final termination letter was sent out. It is essential that we follow the constitution and reflects true members in the book, and we the EXCO are confident we have MABC2.0 and more networking event ahead, we will gain more members ahead.

Datuk Zain suggests that an honorary distinguished life member who has contributed much in MABC should also deserve a voice with a vote. Nordin Abdullah noted Datuk Zain's comments and will propose Article 5 (d) to the EXCO for further review.
